2. The Registered address of the Society is D.No. 61-6-17A, 2nd Lane, Balaji Nagar, VIJAYAWADA-520 013. Any correspondence with the Society shall be made to the said address only.
3. The copy of approved Bye-laws of the society is available in the office premises / website of the society.
